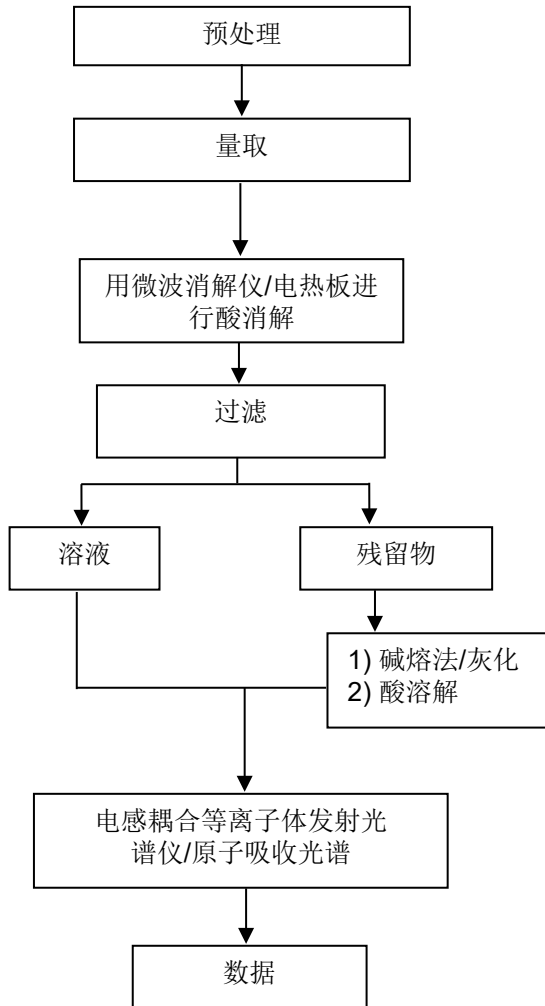

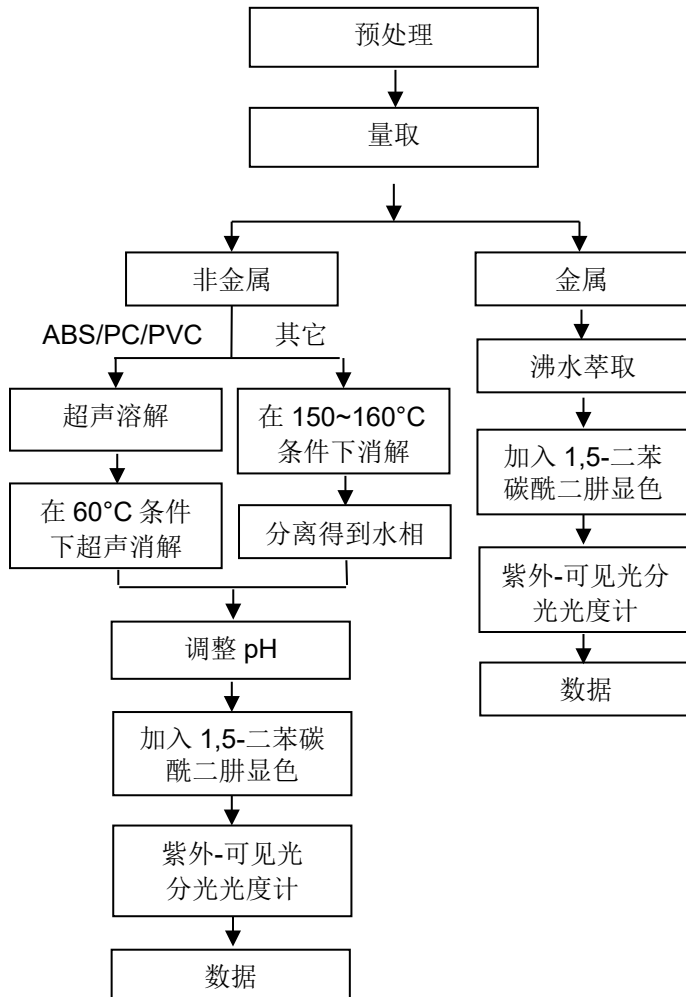

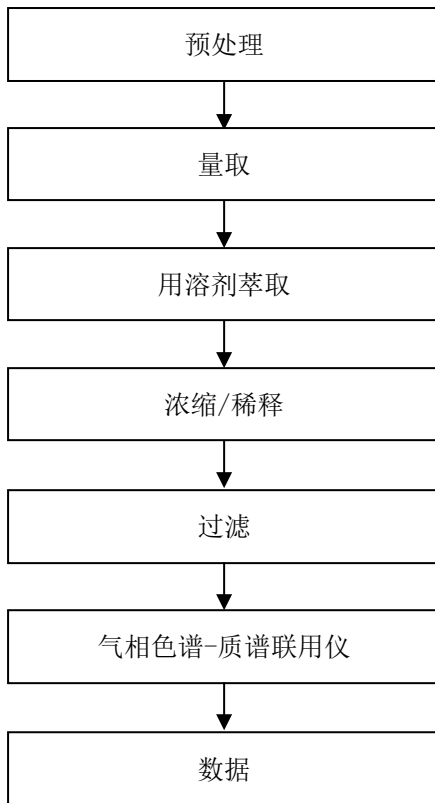
六价铬检测流程图

PBB/PBDE/Phthalates 检测流程图



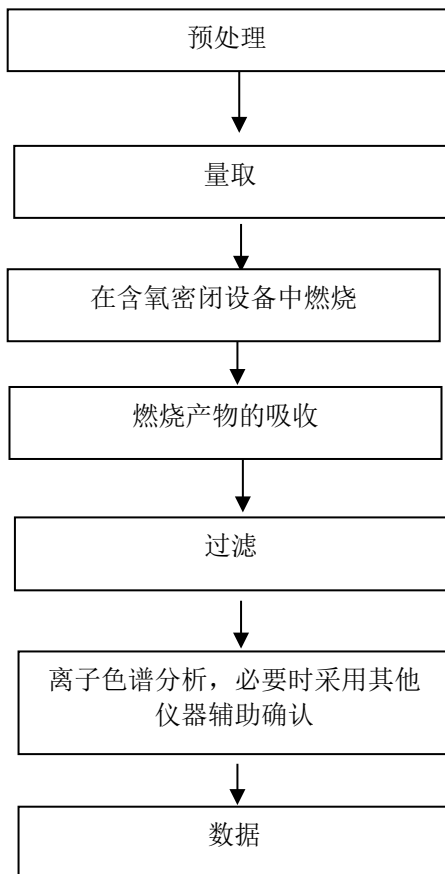

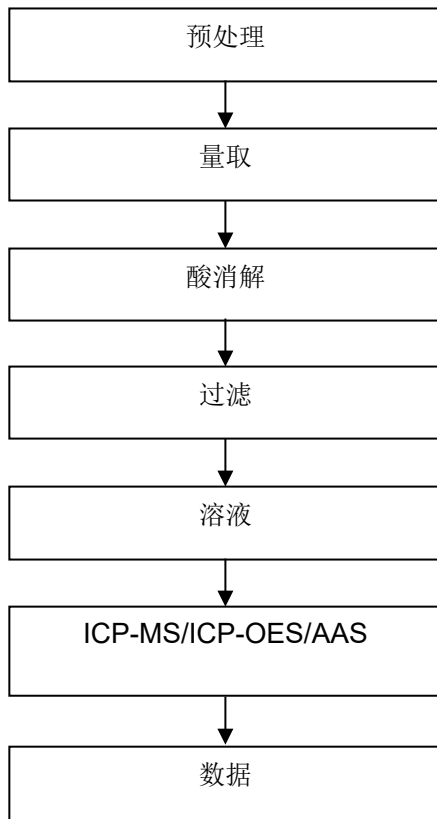

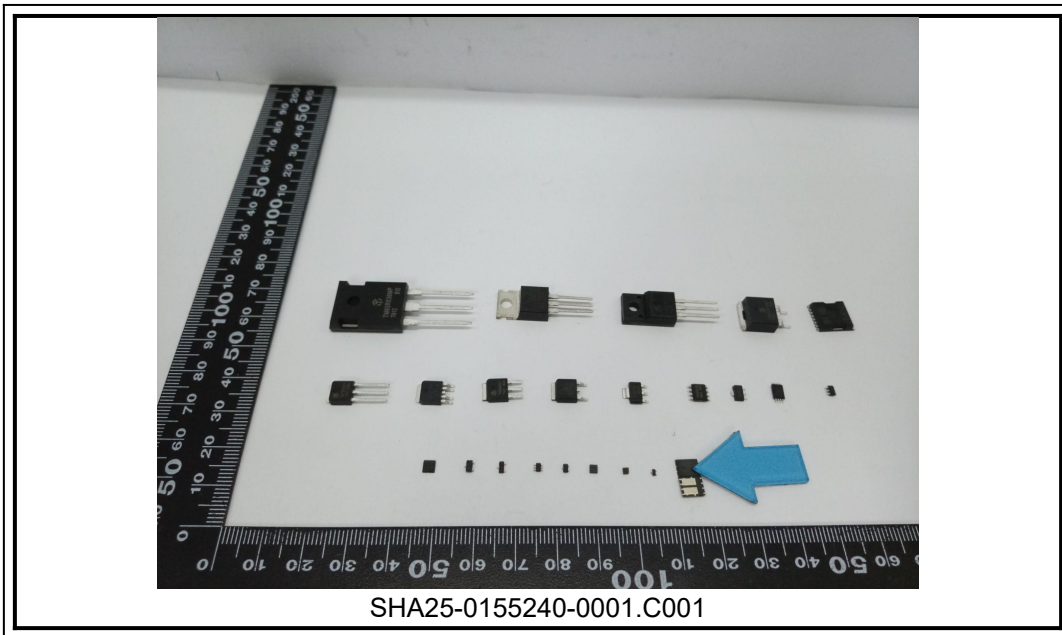
